On July 21, 2008, Capital Southwest Corporation (NASDAQ: CSWC) announced that its board of directors elected current President and CEO Gary L. Martin as chairman of the company's board. Martin, who joined Capital Southwest's board in July 1988, replaces former Chairman William R. Thomas, who has served in a non-executive capacity since his retirement in July 2007.
