This filing relates to a planned merger (the "Merger") between Hewlett-Packard Company ("HP") and Compaq Computer Corporation ("Compaq") pursuant to the terms of an Agreement and Plan of Reorganization, dated as of September 4, 2001 (the "Merger Agreement"), by and among HP, Heloise Merger Corporation and Compaq. The Merger Agreement is on file with the Securities and Exchange Commission as an exhibit to the Current Report on Form 8-K, as amended, filed by Hewlett-Packard Company on September 4, 2001, and is incorporated by reference into this filing.

HP RESPONDS

COMPANY ADDRESSES HEWLETT'S COMPENSATION CLAIMS

Hewlett-Packard issued a statement February 26 in response to Walter Hewlett's claims regarding Carly Fiorina's and Compaq CEO Michael Capellas' compensation, should the proposed merger be completed.

"We agree that shareowners have every right to know compensation information," said the statement, "but we cannot disclose what has not been decided. No new employment contracts exist."

HP's statement noted that as a member of HP's compensation committee, Hewlett "well knows... there are no agreements or understandings regarding the terms of future executive employment agreements" at this time. The company also indicated in the statement that the Board of Directors will make no decisions regarding employment agreements with executives of the new HP until after the merger is closed.
