- (1) On January 3, 2006, the Issuer entered into an agreement with James R. Moore (the "Reporting Person") whereby the Reporting Person was granted a restricted stock award of 17,250 shares of Class A Common Stock pursuant to the Issuer's Amended and Restated Restricted Stock Award Plan (the "Restricted Stock Award Plan").
- (2) The Reporting Person is the direct beneficial owner of 161,416 shares of Class A Common Stock which includes 78,000 restricted shares of Class A Common Stock issued pursuant to the Restricted Stock Award Plan; he is the indirect beneficial owner of 15,009 shares of Class A Common Stock which are owned of record by the Trust Established Under the Urstadt Biddle Properties Inc. Excess Benefits and Deferred Compensation Plan and which are held for the benefit of the Reporting Person. On January 2, 2006, restrictions applicable to a previously reported grant of 5,500 restricted shares each of Class A Common Stock and Common Stock lapsed, resulting in the Reporting Person becoming fully vested in such shares. This resulted in no change in the number of shares beneficially owned by the Reporting Person.
