**Moscow, Russia November 19, 2004 Mechel, Russian metals and mining company, announced today that the Federal Service for the Financial Markets of the Russian Federation has registered its report on the results of an additional issue of securities. The additional shares underlie American Depositary Shares, placed on the New York Stock Exchange in the form of 3<sup>rd</sup> Level American Depositary Receipts on October 29, 2004.**

The report on the results of the additional issue of securities was registered in accordance with the Federal Law on the Securities Market. Registration of the report is the final stage in the issuance of the securities and effectively allows the circulation of the issued securities.

Placement of ordinary non-documentary shares (federal issue registration number 1-01-55005-E-001D dated April 29, 2004) was by closed subscription. The number of placed ordinary shares was 33,301,659 at 6.6325 USD per share.
