Item 1.01 Entry into a Material Definitive Agreement

On June 22, 2005, Advanced Power Technology, Inc. entered into a wafer production agreement with CSMC Manufacturing Co., Ltd. for the provision of foundry services to be performed by CSMC Technologies Fab 1 Co., Ltd., a subsidiary located in Wuxi, Jiangsu Province, China. CSMC Technologies Fab 1 Co., Ltd. will produce and supply wafers to Advanced Power Technology, Inc. according to the terms and conditions of the contract. The contract does not have an expiration date and is cancelable upon twenty-four months prior written notice to terminate the agreement.
