Bally Technologies, Inc. (the Company) hereby requests an extension of time to file its Quarterly Report on Form 10-Q for the fiscal quarter ended September 30, 2007 (the First Quarter 10-Q). The Company dedicated significant resources towards the preparation and filing of its Quarterly Report on Form 10-Q for the fiscal quarter ended March 31, 2007 (the Third Quarter 10-Q) and its Annual Report on Form 10-K for the fiscal year ended June 30, 2007 (the 2007 10-K) which were filed on November 2, 2007. As a result of the delay in filing the Third Quarter 10-Q and 2007 10-K, the Company requires additional time to complete its First Quarter 10-Q. The Company continues to dedicate significant resources to the preparation of the First Quarter 10-Q and the related financial statements.
