Represents the conversion upon vesting of restricted stock awards into common stock (the "Converted Common Stock "). 6,000 options were granted to the Reporting Person on February 28, 2015. Such options vest in three equal installments annually beginning on the first anniversary of the date of grant (2/28/2015).
