### Item 1.01 Entry into a Material Definitive Agreement.

On December 30, 2015, Icahn Enterprises Holdings L.P., a Delaware limited partnership ( Parent ), IEP Parts Acquisition LLC, a Delaware limited liability company and wholly owned subsidiary of Parent ( Merger Sub ) and The Pep Boys Manny, Moe & Jack, a Pennsylvania corporation (the Company ), entered into an Agreement and Plan of Merger (the Merger Agreement ). Pursuant to the Merger Agreement, and upon the terms and subject to the conditions thereof, Parent has agreed that Merger Sub will commence a cash tender offer (the Offer ) to acquire, subject to the terms and conditions of the Merger Agreement, all of the shares of the Company s common stock, par value \$1.00 per share (the Common Stock ), for a purchase price of \$18.50 per share, net to the holders thereof, in cash (the Offer Price ), without interest, less any applicable tax withholding.

Merger Sub has agreed to commence (within the meaning of Rule 14d-2 under the Securities Exchange Act of 1934, as amended (the Exchange Act )) the Offer as promptly as practicable from the date of the Merger Agreement but in any event not later than 5 business days from the date of the Merger Agreement. The consummation of the Offer will be conditioned on (i) there being validly tendered in the Offer (and not validly withdrawn) that number of shares which, together with the shares beneficially owned by Parent, Merger Sub or any of their respective subsidiaries or affiliates, represents at least a majority of the shares of Common Stock (calculated on a fully diluted basis in accordance with the Merger Agreement), (ii) the accuracy of the representations and warranties and compliance with the covenants contained in the Merger Agreement, subject to qualifications, and (iii) other customary conditions.

The Merger Agreement provides that, following the consummation of the Offer, Merger Sub will merge with and into the Company (the Merger ), with the Company surviving the Merger (the closing of the Merger is referred to as the Effective Time ). The consummation of the Merger is subject to certain customary conditions.

At the Effective Time, each share of Common Stock not purchased in the Offer, other than shares held by Parent, Merger Sub or any of their respective subsidiaries or affiliates or by the Company and its subsidiaries (in each case, which will automatically be canceled and retired and will cease to exist) or any shareholder of the Company who duly exercises dissenters rights under Pennsylvania law, will be converted into the right to receive an amount, in cash, equal to the Offer Price, without interest.

Each outstanding option to purchase shares of Common Stock under the Company s stock plans, whether or not exercisable or vested, will become fully vested and exercisable, and will, as of the Effective Time, be cancelled and converted into the right of the holder thereof to receive an amount in cash equal to the product of (i) the excess, if any, of the Offer Price over the applicable per share exercise price of each such option and (ii) the number of shares of Common Stock subject to such option, less any applicable tax withholding. In addition, on the terms and subject to the conditions set forth in the Merger Agreement, any outstanding restricted stock unit awards representing the right to receive shares of Common Stock granted pursuant to the Company s stock plans that vests over the passage of time, and any outstanding performance stock unit award representing the right to receive shares of Common Stock granted pursuant to the Company s stock plans that vests based on the level of achievement of performance goals, will vest (to the extent not vested) and will be cancelled and converted into the right of the holder thereof to receive an amount in cash equal to the product of (i) Offer Price and (ii) the number of units covered by such award that have not been settled or paid immediately prior to the Effective Time, less any applicable tax withholding.

In the Merger Agreement, the Company also granted Merger Sub an option (the Top-Up Option ) to purchase, at a price per share equal to the Offer Price, that number of newly issued shares of Common Stock (the Top-Up Shares ) equal to the lowest number of shares of Common Stock that, when added to the aggregate number of shares of Common Stock owned by Parent, Merger Sub and any of their respective subsidiaries or affiliates at the time of exercise of the Top-Up Option, will constitute one share of Common Stock more than 80% of the shares of Common Stock (calculated on a fully diluted basis in accordance with the Merger Agreement) then outstanding (after giving effect to the issuance of the Top-Up Shares). If following the Offer and the exercise, if any, of the Top-Up Option, Parent, Merger Sub and their respective subsidiaries hold,

in the aggregate, at least 80% of the shares of Common Stock (calculated on a fully diluted basis in accordance with the Merger Agreement), the parties have agreed to take all necessary and appropriate action to complete the Merger as soon as practicable after the

consummation of the Offer without the Company shareholders meeting in accordance with the short form procedures available under Pennsylvania law.

The foregoing description of the Merger Agreement is not complete and is qualified in its entirety by reference to the Merger Agreement, which is attached as Exhibit 2.1 to this report and incorporated herein by reference.

The Merger Agreement and the foregoing description of the Merger Agreement have been included to provide investors and stockholders with information regarding the terms of the Merger Agreement. It is not intended to provide any other factual information about the Company, Parent or Merger Sub. The representations, warranties and covenants contained in the Merger Agreement were made only as of specified dates for the purposes of such agreement, were solely for the benefit of the parties to such agreement and may be subject to qualifications and limitations agreed upon by such parties. In particular, in reviewing the representations, warranties and covenants contained in the Merger Agreement and discussed in the foregoing description, it is important to bear in mind that such representations, warranties and covenants were negotiated with the principal purpose of allocating risk between the parties, rather than establishing matters as facts. Such representations, warranties and covenants may also be subject to a contractual standard of materiality different from those generally applicable to stockholders and reports and documents filed with the U.S. Securities and Exchange Commission (the SEC). Investors are not third-party beneficiaries under the Merger Agreement. Accordingly, investors and stockholders should not rely on such representations, warranties and covenants as characterizations of the actual state of facts or circumstances described therein. Information concerning the subject matter of such representations, warranties and covenants may change after the date of the Merger Agreement, which subsequent information may or may not be fully reflected in the parties public disclosures.

### **Item 8.01 Other Events.**

On December 30, 2015, the Company and Parent issued a joint press release announcing the execution of the Merger Agreement. A copy of the press release is filed as Exhibit 99.1 to this report and is incorporated herein by reference.

### **Notice to Investors**

The Offer has not yet commenced, and this report is neither an offer to purchase nor a solicitation of an offer to sell any shares of the Common Stock or any other securities. On the commencement date of the Offer, Parent and Merger Sub will file a Tender Offer Statement on Schedule TO, including an offer to purchase, a letter of transmittal and related documents, with the SEC and thereafter the Company will file a Solicitation/Recommendation Statement on Schedule 14D-9 with the SEC. Investors and security holders are urged to read both the Tender Offer Statement and the Solicitation/Recommendation Statement regarding the Offer, as they may be amended from time to time, when they become available because they will contain important information. Investors and security holders may obtain a free copy of these statements (when available) and other documents filed with the SEC at the website maintained by the SEC at [www.sec.gov](http://www.sec.gov) or by directing such requests to the Information Agent for the tender offer which will be named in the Tender Offer Statement. Those materials and all other documents filed by the Company, Parent or Merger Sub with the SEC will be available both at no charge on the SEC's web site at [www.sec.gov](http://www.sec.gov).
