**Item 3.01. Notice of Delisting or Failure to Satisfy a Continued Listing Rule or Standard; Transfer of Listing.**

On June 20, 2016, Five Star Quality Care, Inc., or the Company, provided written notice to the New York Stock Exchange, or the NYSE, that the Company expects to voluntarily delist its shares of common stock, par value \$.01 per share, or the Common Shares, from the NYSE effective at the close of trading on June 30, 2016. The Common Shares have been authorized for listing on The NASDAQ Stock Market LLC, or the NASDAQ, and are expected to begin trading on the NASDAQ at the commencement of trading on July 1, 2016. The Common Shares will continue to trade under the symbol FVE.

The Company's Board of Directors approved the delisting of the Common Shares from the NYSE and the listing and trading of the Common Shares on the NASDAQ on June 17, 2016.
