- (1) On January 2, 2007, the Issuer entered into an agreement with Thomas D. Myers (the "Reporting Person") whereby the Reporting Person was granted a restricted stock award of 12,500 shares of Class A Common Stock pursuant to the Issuer's Amended and Restated Restricted Stock Award Plan (the "Restricted Stock Award Plan").
- (2) This figure includes 66,200 restricted shares of Class A Common Stock issued pursuant to the Issuer's Amended and Restated Restricted Stock Award Plan. On January 2, 2007, restrictions applicable to a previous grant of 6,000 restricted shares of Class A Common Stock lapsed resulting in the Reporting Person becoming fully vested in such shares. This resulted in no change in the number of shares beneficially owned by the Reporting Person.
