On May 24, 2018, Bunge Limited (“Bunge”) held its 2018 annual general meeting of shareholders (the “Annual General Meeting”). At the Annual General Meeting, shareholders elected Bunge’s director nominees, approved the appointment of Deloitte & Touche LLP as Bunge’s independent auditors for fiscal year 2018 and approved the advisory vote on executive compensation.
