(1) On November 25, 2013, the reporting person was granted an option to purchase 5,119 shares of the Company's Common Stock. The option vests in three annual installments of 1,707 shares on November 25, 2014; 1,706 shares on November 25, 2015; and 1,706 shares on November 25, 2016.

(2) On March 25, 2015, the reporting person was granted 3,308 shares of Common Stock pursuant to a Restricted Stock Agreement.
