(1) Each restricted stock unit represents a contingent right to receive one share of HP common stock.

As previously reported, on 01/15/09 the reporting person was granted 2,870 restricted stock units ("RSUs"), 1,435 of which vested on 01/15/10, and 1,435 of which will vest on 01/15/11. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The number of derivative securities beneficially owned in column 9 includes 4.4002 dividend equivalent rights at \$52.18 per RSU credited to the reporting person's account on 01/06/10, and two de minimus adjustments of .7496 and .0001 due to fractional rounding of the dividend equivalent rights.
