(1) This option became exercisable in four equal annual installments beginning on this date.

(2) This option is no longer exercisable beginning on this date.

(3) Each restricted stock unit represents a contingent right to receive one share of HP common stock.

(4) On 12/10/10 the reporting person was granted 20,000 restricted stock units ("RSUs"), 10,000 of which will vest on 12/10/11, and 10,000 of which will vest on 12/10/12. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The number of units reported includes dividend equivalent rights accrued but not released since the grant date.

(5) On 06/27/11 the reporting person was granted 85,764 restricted stock units ("RSUs"), 21,441 of which will vest on 10/31/11, 42,882 of which will vest on 10/31/12, and 21,441 of which will vest on 04/30/13. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock.

(6) On 06/27/11 the reporting person was granted 28,588 restricted stock units ("RSUs"), all of which will cliff vest on 06/27/15. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock.
