("HAPC") to be issued to Mr. LaVecchia by HAPC upon the closing of the transactions contemplated by the Stock Purchase Agreement, dated as of September 29, 2006, by and among HAPC, Iceland Acquisition Subsidiary, Inc., InfuSystem, Inc. and I-Flow Corporation (the "Stock Purchase Agreement"). The Option becomes exercisable upon the closing of the transactions contemplated by the Stock Purchase Agreement.
