- Represents performance shares (restricted stock units) that will be converted on a one-for-one basis into shares of Applied Materials, Inc. common stock upon vesting. These performance shares will vest only after the satisfaction of specified performance goals. Provided such goals are achieved, vesting is scheduled to occur no earlier than in four equal annual installments beginning 12/19/10 (subject to continued employment through each vest date).
- (1) Number of shares also includes 185,625 performance shares (restricted stock units) previously reported that in the future will be converted on a one-for-one basis into shares of Applied Materials, Inc. common stock upon vesting, which vesting is scheduled to occur as follows: (a) 39,375 performance shares are scheduled to vest in two equal annual installments beginning 12/19/10; and (b) provided specified performance goals are achieved, 146,250 performance shares are scheduled to vest (i) as to 97,500 shares no earlier than 12/19/10 and (ii) as to 48,750 shares no earlier than 12/19/11 (all vesting is subject to continued employment through each vest date).
