Pursuant to the Plan, on the Effective Date, all shares of the Company's common stock outstanding, par value \$0.01 (the "Old Common Stock"), were cancelled and replaced with shares of common stock, par value \$0.001 (the "New Common Stock"), at a ratio equivalent to a 20 to 1 reverse split of the Company's Old Common Stock. holders of the Old Common Stock were issued warrants (the "Warrants") to purchase up to 10% of the number of issued and outstanding shares of New Common Stock as of the Effective Date. The exchange of Old Common Stock for New Common Stock and Warrants is exempt from Section 16(b) pursuant to Rule 16b-7.
