By letter dated March 30, 2004, the Company reported that holders of Company s Convertible Notes exercised their conversion right. Hence, the financial indebtedness of the Company shall be reduced in US\$ 289,899 and an increase of 531,923 ordinary shares face value pesos 1 (V\$N 1) each was made. The conversion was performed according to terms and conditions established in the prospectus of issuance at the conversion rate of 1.83486 shares, face value pesos 1 per Convertible Note of face value US\$ 1. As a result of that conversion the amount of shares of the Company goes from 233,707,494 to 234,239,417. On the other hand, the amount of registered Convertible Notes is US\$ 92,507,920.
