In particular, cash flows from operations for the three and six months ended November 30, 2007 were \$542.5 million and \$980.9 million, respectively, rather than \$548.4 million and \$986.8 million, respectively, and cash flow from operations for the six months ended November 30, 2007 represented a \$680.5 million increase from the prior year period rather than \$686.4 million.
