#### Item 2.02. Results of Operations and Financial Condition.

These items are presented to exclude the impact of certain non-recurring items on the Company's results. The Company has reported earnings or per share amounts excluding special items and the effective tax rate excluding special items because management believes that these financial measures are more reflective of the Company's operations, provides transparency to investors and enables period-to-period comparability of financial performance. Earnings or per share amounts excluding special items and the effective tax rate excluding special items should not be considered as an alternative to earnings, per share amounts or the effective tax rate determined in accordance with GAAP. The Company has included in the press release reconciliation information for earnings or per share amounts excluding special items and the effective tax rate excluding special items, the non-GAAP financial measures, to earnings, per share amounts or the effective tax rate, as applicable, the most directly comparable financial measures calculated and reported in accordance with GAAP.
