Salary increase for Chief Financial Officer

The Committee approved the following increase in the annual base salary of the Vice President and Chief Financial and Accounting Officer Sharon Birkett: an increase from \$250,000 to \$275,000.

Stock Option grants to Executive Officers

The Committee approved the grant of stock options to purchase the Company s common stock to the two executive officers in the following amounts: (i) Nigel Vinecombe, President and Chief Executive Officer 10,000 options; (ii) Ms. Birkett 5,000 options. All stock options were granted pursuant to the 2003 Stock Incentive Plan and vest in equal annual installments over a five-year period.
