On October 23, 2012, Tom Stevens, KeyCorp s Vice Chair and Chief Administrative Officer, announced that he will retire as a member of KeyCorp s Board of Directors effective as of KeyCorp s 2013 annual meeting of shareholders (May 16, 2013) and as Chief Administrative Officer on June 30, 2013.
