# Item 5.02 Departure of Directors or Certain Officers; Election of Directors; Appointment of Certain Officers; Compensatory Arrangements of Certain Officers.

On June 24, 2014, the Board of Directors of Health Care REIT, Inc. (the Company ) appointed Geoffrey G. Meyers as a member of the Board of Directors, which increased the size of the Board of Directors from nine to ten directors. Mr. Meyers will be a member of the Compensation, Investment and Planning Committees.

Mr. Meyers will be compensated for his service as a director on the same basis as other non-employee directors of the Company. Compensation for the Company s non-employee directors is described in the Company s Proxy Statement for its 2014 Annual Meeting of Shareholders as filed with the Securities and Exchange Commission on March 21, 2014.

In connection with the appointment, the Company will enter into an indemnification agreement with Mr. Meyers. The agreement will be substantially identical to the agreements previously entered into between the Company and its other directors and will generally provide that the Company will, in certain circumstances, indemnify Mr. Meyers against any and all expenses, judgments, fines, penalties and amounts paid in settlement arising out of his service to the Company. Also, the agreement will provide for the advancement of expenses in connection with a threatened, pending or completed action, suit or proceeding.
