**VALEANT PHARMACEUTICALS AND PERSHING SQUARE RESPOND TO  
FRIVOLOUS ALLERGAN LAWSUIT**

**Another Desperate Allergan Attempt to Interfere with the Special Meeting**

LAVAL, Quebec and NEW YORK, New York, August 1, 2014 Valeant Pharmaceuticals International, Inc. (NYSE/TSX: VRX) and Pershing Square Capital Management, L.P. today responded to the filing of a federal lawsuit by Allergan, Inc. (NYSE: AGN) in California. The complaint makes baseless claims about Valeant and Pershing Square regarding the tender offer rules.

Allergan's true purpose in bringing the litigation is an attempt to interfere with shareholders' efforts to call a special meeting. That purpose is made clear in a separate letter Allergan sent today to the Delaware Court of Chancery. In that letter, Allergan noted that its bylaws provide that the Corporate Secretary shall consider ineffective any Special Meeting Requests that are made in a manner that involved a violation of Regulation 14A under the Exch: 1;
