Issuer: Constellation Brands, Inc.

Principal Amount: \$400,000,000 aggregate principal amount.

Title of Securities: 3.875% Senior Notes due 2019.

Final Maturity Date: November 15, 2019.

Public Offering Price: 100% of principal amount plus accrued interest, if any, from and including November 3, 2014.

Interest: 3.875% per annum.

Interest Payment Dates: November 15 and May 15.

Record Dates: November 1 and May 1.

First Interest Payment Date: May 15, 2015.

Optional Redemption: The Company may redeem some or all of the notes at any time at a redemption price equal to the greater of

- 100% of the principal amount of the notes being redeemed; and
- the sum of the present values of the remaining scheduled payments of principal and interest on the notes being redeemed (excluding interest accrued to the redemption date) from the redemption date to the maturity date discounted to the date of redemption on a semi-annual basis (assuming a 360-day year consisting of twelve 30-day months) at a discount rate equal to the Treasury Rate plus 50 basis points.

The Company will also pay accrued and unpaid interest on the notes to the redemption date.
