New Medtronic Leader Interview with Mike Coyle

### **What Is Your Background?**

So I'm an engineer by training. I've spent virtually my whole career in the cardiovascular space, mostly for competitors of Medtronic. I've really just spent the last 5 years here trying to build on the breadth and scale that Medtronic has in the cardiovascular space.

### **Why Did You Pursue a Career In Healthcare?**

I remember vividly when I was graduating with my undergraduate degree in Chemical Engineering getting an opportunity to take a job in the chemical industry or in the pharmaceutical industry or in the petroleum industry. And I really decided if I was going to be working hard all day, I'd rather do it in an area where I could really affect people's lives as in the healthcare space.

### **What Is a Key Area of Passion for You?**

While I love all the aspects of the Medtronic core strategies, I have to say that the one that really gets my juices flowing is the idea of therapy innovation, to be able to take a, unmet clinical need identified by a physician and match it up with what engineers can do and really create a solution that really impacts people's lives.

### **What Do You Think of This Deal and the New Medtronic?**

Medtronic is going to have unique breadth and capability across the cardiovascular space, the neuroscience space, the general surgery space, and the idea that we'll be able to win in each individually but then collectively, bring that to governments around the world, to payers around the world, to healthcare CEOs around the world. There's really a unique opportunity that no other company has.

### **What Do You See as the Most Exciting Opportunities Ahead?**

To be the most exciting thing is to take complementary capabilities that each of the two companies have and put them together. Like the strong therapy development programs that we have around key innovations like our LINQ insertable monitor as well as the IN.PACT Admiral drug-coated balloon and put those together with the field capabilities that we have but within the peripheral vascular space as well as in the neurovascular space that Covidien brings to the company.

**What Are the Key Challenges We Will Need to Overcome?**

Together, this is going to be a very big company and I think the key is going to be to maintain the intimacy we have with our physician customers as we take advantage of the size and scale we have as a combined organization.

**What Is Your Leadership Style?**

I'm very committed to being very clear about the core strategies that we have and the roles and responsibilities that I expect people to execute on. But then I want to delegate that authority down to the people who can actually make it happen on the ground.

**What Activities/Interests Do You Enjoy Outside of Work?**

Well, I have 2 children, one who is just starting college and one who just is finishing up high school. My life for the better part of the last 15 years has been focused on everything that they do. So at the moment, that's my key area of focus outside of work. And when they're both off to college, I think I'll have to find some other things to do.
