ITEM 1. SECURITY AND ISSUER.

This Amendment No. 1 to Schedule 13D (<u>Amendment No.1</u>) amends and supplements the statement on Schedule 13D originally filed with the Securities and Exchange Commission on March 15, 2017 (the <u>Original Schedule 13D</u>) by the Reporting Persons (as defined below) relating to shares of common stock, par value \$0.01 per share (<u>Common Stock</u>), of Hilton Worldwide Holdings Inc., a Delaware corporation (the <u>Iss</u>uer). The Reporting Persons include: (i) HNA Group Co., Ltd. (<u>HNA Group</u>), (ii) HNA Tourism Group Co., Ltd. (<u>HNA Tourism HK</u>), (iv) HNA HLT Holdco III Limited (<u>SPV III</u>), (v) HNA HLT Holdco II LLC (<u>SPV II</u>), and (vi) HNA HLT Holdco I LLC (<u>SPV II</u>), and together with SPV III and SPV II, the SPVs). Except as otherwise specified in Amendment No.1, all items in the Original Schedule 13D are unchanged. Unless otherwise indicated, each capitalized term used but not defined herein shall have the meaning assigned to such term in the Original Schedule 13D.

ITEM 4. PURPOSE OF TRANSACTION.

Item 4 of the Original Schedule 13D is hereby amended by adding thereto and incorporating therein by reference the information set forth in Item 6 below.

ITEM 6. CONTRACTS, ARRANGEMENTS, UNDERSTANDINGS OR RELATIONSHIPS WITH RESPECT TO SECURITIES OF THE ISSUER.

Item 6 of the Original Schedule 13D is hereby amended by adding thereto the information set forth below.

HNA HLT Holdco IV LLC, a Delaware limited liability company and an affiliate of HNA Tourism (the <u>Borrower</u>), SPV I (the <u>Pledgor</u>) and SPV II entered into an Amended and Restated Margin Loan Agreement, dated as of December 22, 2017 (as amended from time to time, the <u>A/R Loan Agreement</u>) with the lenders party thereto (each, a <u>Lender</u> and collectively, the <u>Lenders</u>) and JPMorgan Chase Bank, N.A., London Branch, as administrative agent and calculation agent (the <u>Administrative Agent</u>). The A/R Loan Agreement fully amends and restates the Loan Agreement referred to in the Original Schedule 13D. The A/R Loan Agreement increases the maximum borrowing from \$3,000,000,000 to \$3,500,000,000. The Borrower closed on the borrowing of the additional \$500,000,000 on December 27, 2017.

The description of the A/R Loan Agreement contained in this Item 6 is not intended to be complete and is qualified in its entirety by reference to that agreement, which is attached hereto as an exhibit and incorporated herein by reference.
