All of the 1,883 shares were acquired by the Reporting Person pursuant to the 1998 RemyTemp, Inc. Deferred Compensation and Stock Ownership Plan for Outside Directors (the "Director Plan"). Under the Director Plan, non-employee, non-officer directors received an annual retainer fee in the form of shares of Class A Common Stock valued at the date the Reporting Person was re-elected to the Board with such shares issued following the next annual meeting of shareholders provided that the Reporting Person has remained a director during such time. All shares are held in trust on a deferred basis until the Reporting Person is no longer a director of RemyTemp, Inc.
