These RSUs (A-E) vest annually in four equal installments beginning 1 year after grant date. (F) 8,000 RSUs granted on May 4, 2011; (G) 8,000 RSUs granted on May 2, 2012; (H) 8,000 RSUs granted on May 1, 2013. These RSUs (F-H) vested 100% on the first anniversary of the grant date. As of this filing, 50,500 RSU have vested.
