- Represents 32,846 restricted stock units granted to the reporting person under the issuer's 2015 Equity Incentive Plan. Each restricted stock unit represents the contingent right to receive one share of the issuer's common stock. The restricted stock units vest as follows:
- (1) 6,568 of the restricted stock units vest in three equal annual installments on March 7, 2020, March 7, 2021 and March 7, 2022, provided that the reporting person remains employed by the issuer as of each vesting date, and (ii) up to 26,278 of the restricted stock units vest in three equal annual installments beginning on the date in 2020 that the issuer's compensation committee certifies that certain performance metrics are achieved, provided that the reporting person remains employed by the issuer as of each vesting date.
 - (2) Represents shares withheld by the issuer to cover tax withholding obligations upon vesting of a restricted stock unit award.
 - (3) Adjusted to reflect 5,481 restricted stock units that were cancelled as certain performance metrics relating to the vesting of such awards was not achieved.
