Stetson, Chicago, IL 60601, a wholly-owned subsidiary of Piper Jaffray Companies and an investment adviser registered under Section 203 of the Investment Advisers Act of 1940, is the beneficial owner of 1,073,165 shares or 5.9% of the Common Units Representing Limited Partner Interests outstanding of JP Energy Partners LP LP ("the Company") as a result of acting as investment adviser to various clients.
