Continuing the Notice to Shareholders from December 17, 2015, published in the editions of December 18, 2015 of the newspapers Valor Econômico and Diário Oficial do Estado de São Paulo, Telefônica Brasil S.A. ("Company") announces to its shareholders that no shares were purchased within the Program for the Buyback of Shares to be held in treasury for subsequent sale and/or cancellation, according to the Material Fact disclosed to the market on December 09, 2015.
