(a) Amount beneficially owned:

As of the close of business on February 1, 2016, The Lion Fund owned directly 5,685,170 shares of Common Stock.

BCC is the general partner of The Lion Fund. Mr. Biglari is the Chairman and Chief Executive Officer of BCC and has investment discretion over the securities owned by The Lion Fund. By virtue of these relationships, BCC and Mr. Biglari may be deemed to beneficially own the 5,685,170 shares of Common Stock owned directly by The Lion Fund.

(b) Percent of class:

Based on 106,346,001 shares of Common Stock outstanding as of November 5, 2015, as disclosed by the Issuer in its Quarterly Report on Form 10-Q filed with the Securities and Exchange Commission on November 6, 2015.

As of the close of business on February 1, 2016, The Lion Fund owned directly approximately 5.3% of the outstanding shares of Common Stock. By virtue of the relationships described above, BCC and Mr. Biglari may be deemed to beneficially own approximately 5.3% of the outstanding shares of Common Stock.
