On December 31, 2013, 66,667 restricted stock units held by Mr. Morhaime vested. Pursuant to the terms of his restricted stock unit award, the Company withheld 34,787 of the shares otherwise deliverable to him in order to satisfy the resulting tax withholding obligation.

 - (3) Following the transactions reported on this Form 4, Mr. Morhaime indirectly held (through the Michael Morhaime Revocable Trust) 173,767 shares of the Company's common stock.
