#### Item 2.01 Completion of Acquisition or Disposition of Assets.

Summit Acquisition.

On October 1, 2007, Legacy Reserves Operating LP, a wholly owned subsidiary of Legacy Reserves LP ("Legacy"), closed its previously announced acquisition (the "Summit Acquisition") of certain oil and natural gas producing properties located in the Permian Basin from private parties for an aggregate purchase price of approximately \$13.5 million, subject to customary purchase price adjustments, paid in cash.
