



Sabby Management, LLC and Hal Mintz do not directly own any shares of Common Stock, but each indirectly owns 11,000,000 shares of Common Stock. Sabby Management, LLC, a Delaware limited liability company, indirectly owns 11,000,000 shares of Common Stock because it serves as the investment manager of Sabby Healthcare Volatility Master Fund, Ltd. and Sabby Volatility Warrant Master Fund, Ltd., Cayman Islands companies that directly hold 7,333,340 and 3,666,660 shares of Common Stock, respectively. Mr. Mintz indirectly owns 11,000,000 shares of Common Stock in his capacity as manager of Sabby Management, LLC.
