(1) Release and settlement of restricted stock units ("RSUs") granted to the Reporting Person on February 15, 2018, the grant of which was previously reported by the Reporting Person on a Form 4.

(2) Represents the aggregate number of shares sold by the Reporting Person to cover taxes and fees due upon the release and settlement of restricted stock units over several days. The Reporting Person did not sell or otherwise dispose of any of the shares reported on this Form 4 for any reason other than to cover required taxes and fees.

Shares of the Issuer's Class B common stock will be delivered to the Reporting Person following vesting, at which time shares will be sold by the Reporting Person to cover any tax withholding obligations.
