On November 16, 2018, Generex Biotechnology Corporation ("Generex") revised record, payment and ex-dividend dates for the common stock dividend on its shares of common stock, par value \$.001 per share, at a ratio of 20 for 1. The Record Date for the determination of the holders of the Company's common stock entitled to participate in the stock dividend will now be Tuesday, November 20, 2018. The dividend Payment Date will be Friday, November 30, 2018. The Company anticipates the ex-dividend date will be Monday, December 3, 2018.

On November 16, 2018, Generex issued a press release, a copy of which is furnished herewith as Exhibit 99.1, announcing the new dates for the common stock dividend.
