[3] One of the investment management contracts that relates to these securities provides that

the applicable FRI affiliate share investment power over the securities held in the

account are less than 5% of the outstanding shares of the class. In addition, FRI does

not believe that such contract causes such client or unaffiliated entity to be part of a

group with FRI or any FRI affiliate within the meaning of Rule 13d 5 under the Act.
