- (1) This amended Form 4 is being filed to correct an administrative error in the grant date, exercise price, date of vesting and expiration date of this option grant.

The Binomial Lattice option valuation model will be used to estimate the fair value of the option. This model requires the input of certain assumptions, including risk-free interest rate, volatility, dividend yield, and expected life.
