On December 18, 2007 and November 6, 2008, the reporting person received two separate grants of Restricted Stock Units ("RSUs") that each represent a contingent right to receive one share of the Company's common stock. The RSUs were granted pursuant to the 2004

On June 18, 2009, in accordance with the terms of the RSU agreement, 1/8 of the shares vested and the Company withheld an equivalent amount of RSUs at fair market value to pay the minimum tax withholding requirements for the reporting person.
