- (1) As disclosed by CTIC in its proxy statement filed with the SEC on April 9, 2010, in December 2009 CTIC granted a bonus opportunity to the reporting person that was payable in shares of CTIC stock upon the achievement of certain performance goals before December 31, 2011.
