IEH Corporation (the "Registrant") files this report for a 5-day extension for filing its Quarterly Report on Form 10-Q for the period ended June 27, 2014 ("Form 10-Q"). The Registrant will not be in position to file its Form 10-Q by the prescribed filing date without unreasonable effort or expense due to the delay experienced by the Registrant in completing its financial statements for the period ended June 27, 2014. This has resulted in a delay by the Registrant in obtaining the review of such financial statements by its independent registered public accounting firm. Therefore, Registrant's management is unable to finalize the financial statements and prepare its discussion and analysis in sufficient time to file the Form 10-Q by the prescribed filing date. The Registrant anticipates that it will file its Form 10-Q no later than fifth calendar day following the prescribed filing date.

Net sales for the quarter ended June 27, 2014 is anticipated to decrease as compared with the quarter ended June 28, 2013 in which we reported net sales of \$4,090,639. However, we anticipate that net sales for the period ended June 27, 2014 will be in the range of \$3,900,000 to \$3,950,000. The decrease in revenues can be attributed to a decrease in commercial orders during the quarter.

Operating income for the quarter ended June 27, 2014 is anticipated to decrease as compared with the quarter ended June 28, 2013 in which we reported operating income of \$895,101. However, we anticipate that operating income for the quarter ended June 27, 2014 will be in the range of \$700,000 to \$710,000. The decrease in operating income for the current three-month period can be attributed primarily to a decrease in commercial orders during the current quarter.

Net income for the quarter ended June 27, 2014 is anticipated to decrease as compared with the quarter ended June 28, 2013 in which we reported net income of \$524,319. However, we anticipate that net income for the period ended June 27, 2014 will be in the range of approximately \$350,000 to \$400,000 or \$0.15 to \$0.17 per share. The decrease in net income for the current three-month period can be attributed primarily to a decrease in commercial orders during the current quarter.
