Gary Hromadko, an affiliate of Crosslink, is a director of the Issuer and serves as the representative of the Reporting Persons on the Issuer's board. These securities were granted to Crosslink in connection with Mr. Hromadko's service as a director. The reporting persons are filing this Form 4 jointly, but not as a group, and each of them expressly disclaims membership in a group, within the meaning of Rule 13d-5(b) under the Securities Exchange Act of 1934, as amended. The Reporting Persons disclaim beneficial ownership of these securities except to the extent of their pecuniary interest therein.
