Item 2.03. Creation of a Direct Financial Obligation or an Obligation under an Off-Balance Sheet Arrangement of a Registrant

On October 26, 2005, Arbor Realty Trust, Inc. (the Company), as guarantor, and Arbor Realty SR, Inc., as seller, entered into a \$150 million master repurchase agreement with a financial institution (the Repurchase Agreement). The facility has a rolling one-year term not to exceed three years from the effective date of the agreement and bears interest at a spread over LIBOR. Subject to the terms and conditions thereof, the Repurchase Agreement provides for the sale and repurchase of first lien mortgages, commercial mezzanine loans, B-notes, participation interests in the foregoing, and other mutually agreed upon collateral.

The facility requires that the Company satisfy certain financial covenants including minimum net worth, debt-to-equity ratios, and other restrictions and covenants that are normal and customary.
