#### Item 8.01 Other Events.

On June 6, 2011, Medicis Pharmaceutical Corporation (the Company ), certain of its current officers and directors who are named in the actions, and the Company s outside auditors entered into Memoranda of Understanding (the MOUs ) with the plaintiffs representatives to memorialize an agreement in principle to settle the consolidated stockholder class action litigation pending in U.S. District Court for the District of Arizona (the Class Action Litigation ), as well as both stockholder derivative lawsuits pending in Superior Court of the State of Arizona (the Derivative Lawsuits ). The Class Action Litigation and the Derivative Lawsuits are more fully described in the Company s Quarterly Report on Form 10-Q for the period ended March 31, 2011. Under the terms of these settlement agreements, which remain subject to approval by the applicable courts among other customary conditions, the Company s portion of the Class Action Litigation settlement will be paid entirely by insurance. The Company s outside auditors also will contribute to this settlement. The Derivative Lawsuits settlement, the only financial component of which involves payment of plaintiffs attorneys fees, also will be paid entirely by insurance. The Company itself is not required to make any payments to fund the settlements of the Class Action Litigation or the Derivative Lawsuits. The settlement of the Derivative Lawsuits reflects certain control and other enhancements undertaken by the Company in connection with and subsequent to the restatement of its consolidated financial statements in 2008. The settlement agreements contain no admission of liability by the Company or the named individuals in the respective actions, the allegations of which are expressly denied in the MOUs.
