On June 28, 2002, in accordance with the order of the Securities and Exchange Commission 27490 (the "Order"), National Grid Group plc ("National Grid") submitted its report for the period ending June 2002 (the "June 2002 Report"). National Grid is filing this amendment to correct certain items contained in the June 2002 Report.

Common stockholders' funds for National Grid (US) Investments were overstated by \$35.9M in the June 2002 Report (to the June 2002 Report). The corrected amount is \$97.5M with total capitalization and the percentage of short-term debt for National Grid (US) Investments revised accordingly. National Grid hereby amends the June 2002 Report.

Exhibit A-3 of the June 2002 Report is hereby deleted and is replaced in its entirety by Exhibit A-3 of this amendment.

In this amendment a conversion ratio of 1 GBP to 1.42 US Dollars has been used. The exchange rate should not be taken to mean that the pound sterling amounts have been, could have been, or could have been converted at other rates.
