#### Item 1. Security and Issuer.

The title of the class of security to which this statement relates is the Common Stock of DATATRAK INTERNATIONAL, INC, whose principal executive offices are located at 20600 Chagrin Boulevard, Cleveland, Ohio 44122.

#### Item 2. Identity and Background

This statement is filed by Peter E. Salas, a United States citizen with a business address at Dolphin Asset Management Corp., 129 East 17th Street, NY, NY 10003, as General Partner of Dolphin Offshore Partners, L.P. His present principal occupation is General Partner of Dolphin Offshore Partners, L.P. During the last five years, Mr. Salas has not been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors) nor been a party to a civil proceeding of a judicial or administrative body of competent jurisdiction subjecting him to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, Federal or State securities laws or finding any violation with respect to such laws.
