C) PRINCIPAL BUSINESS AND OCCUPATION - INVESTMENT MANAGEMENT FOR INDIVIDUALS, PENSION AND PROFIT SHARING PLANS, CORPORATIONS, ENDOWMENTS, TRUST AND OTHERS, SPECIALIZING IN CONSERVATIVE ASSET MANAGEMENT (I.E. FIXED INCOME INVESTMENTS).

ITEM 3 SOURCE AND AMOUNT OF FUNDS OR OTHER CONSIDERATIONS
KIM, AN INDEPENDENT INVESTMENT ADVISOR, HAS ACCUMULATED SHARES OF CLM ON BEHALF OF ACCOUNTS THAT ARE MANAGED BY KIM ("THE ACCOUNTS") UNDER LIMITED POWERS OF ATTORNEY. ALL FUNDS THAT HAVE BEEN UTILIZED IN MAKING SUCH PURCHASES ARE FROM SUCH ACCOUNTS.

ITEM 4 PURPOSE OF TRANSACTION

KIM HAS PURCHASED SHARES FOR INVESTMENT PURPOSES. BEING A CLOSED-END FUND SPECIALIST THE PROFILE OF CLM FIT THE INVESTMENT GUIDELINES FOR VARIOUS ACCOUNTS. SHARES HAVE BEEN ACQUIRED SINCE OCTOBER 23, 1989.

ITEM 5 INTEREST IN SECURITIES OF THE ISSUER

A) AS OF THE DATE OF THIS REPORT, KIM OWNS 378,285 SHARES, WHICH REPRESENTS 9.54% OF THE OUTSTANDING SHARES.

KARPUS INVESTMENT MANAGEMENT PROFIT SHARING PLAN OWNS 2,750 SHARES. 200 PURCHASED ON JUNE 24, 1993 @ 9.125, 400 PURCHASED ON AUGUST 26, 1993 @ 9.875, 300 PURCHASED ON JANUARY 29, 1998, 500 PURCHASED ON APRIL 29, 1999 @ 13.125, DECEMBER 11, 2000 AT \$10.65 PER SHARE (1000 SHARES), AND DECEMBER 20 AT \$10.75 PER SHARE (500 SHARES). ON MARCH 27, 2000 150 SHARES WERE SOLD AT \$14.20 PER SHARE.

B) KIM HAS THE SOLE POWER TO DISPOSE OF AND TO VOTE ALL OF SUCH SHARES UNDER LIMITED POWERS OF ATTORNEY.

C) THE FIRST OPEN MARKET PURCHASE OCCURRED ON OCTOBER 23, 1989 OPEN MARKET PURCHASES FOR THE LAST 90 DAYS FOR THE ACCOUNTS. THERE HAVE BEEN NO DISPOSITIONS AND NO ACQUISITIONS, OTHER THAN BY SUCH OPEN MARKET PURCHASES.
