Item 5.07 Submission of Matters to a Vote of Security Holders.

IntelGenx Technologies Corp. (the Company or IntelGenx) held its Annual Meeting of Shareholders on May 10, 2016 (the Annual Meeting), for those who were shareholders of the Company at the close of business on March 11, 2016 (the Record Date), pursuant to notice and proxy materials duly mailed to them. As of the Record Date, there were 63,615,256 shares outstanding of the Company s common stock at \$0.00001 par value (the IntelGenx Common Stock). At the 2016 Annual Meeting, Record Date shareholders holding 46,411,547 shares (72,957%) of the IntelGenx Common Stock were present in person or per proxy. Each such shareholder was entitled to one vote for each share of the IntelGenx Common Stock held on the Record Day.

At the 2016 Annual Meeting, the following matters were submitted to votes of the Company s shareholders:

- (i) the election of six directors,
 - (ii) the ratification of Richter LLP as the Company s independent auditors for the fiscal year ending December 31, 2016,
 - (iii) the advisory vote on executive compensation.
